SECTION 1. That the recommendation of the Board of Local Improvements of the City of Chicago, providing for said improvement, together with the estimate of the cost hereof, including the harful expenses attending the same, made by the engineer of said Board both hereto attached, he and the same are hereby approved.

SECTION 2. That said improvement shall be made and the cost thereof, including the lawful expenses attending the same, be paid by special assessment in accordance with an Act of the General Assembly of the State of Illinois, entitled, "An Act Concerning Local Improvements," approved June 14th, A. D. 1897, and the amendments thereto, and that of said special assessment of the sum of

THREE THOUSAND SEVEN HUNDRED EIGHTY-EIGHT AND NO ONE-HUNDREDTHS DOLLARS

(\$3,788.00)

not exceeding live (5) per certum of the amount of said assessment as finally determined after the completion of said improvement in accordance with Article 9-2 of said Act. shall be applied toward the payment of the cost of making, levying and collecting said special assessment, and of letting and executing contracts, advertising, clerical hire, entitiving and inspection, court costs and deficiency in interest in the matter of said special assessment, in accordance with the provisions of said Act.

SECTION 3. That the aggregate amount herein ordered to be assessed against the property, and also the assessment on each lot and parcel of land therein assessed shall be divided into five (5) installments in the manner provided by the statute in such case. Tade and provided, and each of said installments shall bear interest at the rate of seven (7) per centum per annum according to law until paid, or as otherwise provided by law.

SECTION 4. That for the purpose of anticipating the collection of the second and succeeding installments of said assessment for said improvement (except such part, if any that is chargeable to the City of Chicago for public benefits to public lands), honds shall be issued payoute out of said installments bearing interest at the rate of seven (7) pet centum per annum, or as otherwise provided by law, payable annually, and signed by the Mayor and by the President of the Board of Local Improvement, countersigned by the City Competoller and attested by the City Clerk under the corporate seal of the City of Chicago, Said bonds shall be issued in accordance with and shall in all respects conform to the provision of the Act of the General Assembly of the State of Illinois, entitled, "An Act Concerning Local Improvements", approved June 19th, A D. 1897, and the amendments thereto.

SECTION 5. That the Corporation Counsel be and he is hereby directed to file a petition in the Circuit Court of Cook County, Illinois, in the name of the City of Chicago, praying that steps may be taken to levy a special assessment for said improvement in accordance with the provisions of this ordinance and in the manner prescribed by law.

SECTION 6. That all ordinances, or party of ordinances, conflicting with this ordinance be and the same are hereby repealed.

SECTION 7. This naturance shall be in force from and after its passage.


