

Excerpts From Internal Revenue Co/A

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to , pay the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penalty, tegether with any costs that may accrue in addition thersto) shall be a lien in Sever of the United States upon all property and rights to property, whether real or personal, belonging to much parson.

Sec. 6322, Period Of Lien.

Unless another date is specifically fixed by law, the lies imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lance of time

Sec. 6323 Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Meshanic's Lienors, And Judgment Lien Creditors. — The lien imposed by section 6321 shall not be valid sessential lienor, or judgment lien creditor until notice thereof which reside the requirements of subsection (f) has been filed by the Secretary.

(n) Place For Fitting Notice: Form.-

(1) Place For Filing - The notice referred to in subsection (a) shall be filed -

(A) Under State Laws

(i) Real Property - in the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the preparty subject to the lien is situated; and

(ii) Personal Property - in the case of personal property, whether tangible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is eltusted;

(B) With Clerk Of District Court - in the office of the clerk of the United States district court for the judicial district in which the property subject to flen is situated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbia - In he affice at the Recorder of Doods of the District of Columbia, if the property subject to the lien is situated in the District of Cokambia
