AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO  
THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

WHEREAS, the corporate authorities of the Village of Glenview, have determined that annexation of certain territory in Cook County, Illinois, hereinafter described, is in the public interest and in the best interests of the Village of Glenview, and will promote the public health, safety and welfare of the Village and its residents; and

WHEREAS, the corporate authorities of the Village of Glenview, a home rule municipality, find that the following described territory is unincorporated territory containing less than 60 acres, and is wholly bounded by the Village of Glenview.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that

Section 1: The facts and statements contained in the preamble to this ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

Section 2: The unincorporated territory, containing less than 60 acres and wholly bounded by the Village of Glenview, and is legally described as follows:

THAT PART OF THE WEST 1/2 OF THE NORTHEAST 1/4, AND THE EAST 1/2 OF THE NORTHWEST 1/4 OF SECTION 33, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHEAST CORNER OF LOT 7 IN GLENVIEW WESTBROOK, A SUBDIVISION OF PART OF THE WEST 1/2 OF THE SOUTHWEST 1/4 OF THE NORTHEAST 1/4 OF SAID SECTION 33, ACCORDING TO THE PLAT THEREOF RECORDED JANUARY 22, 1954 AS DOCUMENT NO. 15817689; THENCE WESTERLY ALONG THE SOUTH LINE OF LOTS 1 THROUGH 7, INCLUSIVE, IN SAID GLENVIEW WESTBROOK TO AN INTERSECTION WITH THE EAST LINE OF GREENWOOD ROAD, SAID EAST LINE BEING 50.00 FEET, AS MEASURED AT RIGHT ANGLES, EAST OF AND PARALLEL WITH THE WEST LINE OF SAID NORTHEAST 1/4; THENCE NORTHERLY ALONG SAID EAST LINE OF GREENWOOD ROAD TO AN INTERSECTION WITH THE EASTERLY EXTENSION OF THE SOUTH LINE OF THE NORTH 1/2 OF THE SOUTH 1/2 OF THE NORTHWEST 1/4 OF SAID SECTION 33; THENCE WESTERLY ALONG SAID EASTERLY EXTENSION AND ALONG SAID LAST DESCRIBED SOUTH LINE, 200.00 FEET TO AN INTERSECTION WITH THE WEST LINE OF THE EAST 1/2 OF THE SOUTH 1/2 OF SAID NORTHWEST 1/4; THENCE NORTHERLY ALONG SAID LAST DESCRIBED WEST LINE, 100.00 FEET TO AN INTERSECTION WITH THE NORTH LINE OF THE SOUTH 1/2 OF THE NORTHWEST 1/4 OF SAID SECTION 33; THENCE EASTERLY ALONG SAID LAST DESCRIBED NORTH LINE AND SAID NORTH LINE EXTENDED, 200.00 FEET TO AN INTERSECTION WITH THE EAST LINE OF GREENWOOD ROAD, AFORESAID; THENCE NORTHERLY ALONG SAID LAST DESCRIBED EAST LINE TO AN INTERSECTION WITH THE EASTERLY EXTENSION OF THE SOUTH LINE OF THE NORTH 1/2 OF THE NORTHWEST 1/4 OF SAID SECTION 33; THENCE WESTERLY ALONG SAID EASTERLY EXTENSION AND SAID LAST DESCRIBED SOUTH LINE TO AN INTERSECTION WITH THE WEST LINE OF THE EAST 1/4 OF SAID NORTHWEST 1/4; THENCE NORTHERLY ALONG SAID LAST DESCRIBED WEST LINE TO AN INTERSECTION WITH THE SOUTH LINE OF THE NORTH 1/2 OF THE EAST 1/4 OF SAID NORTHWEST 1/4; THENCE EASTERLY ALONG SAID LAST DESCRIBED SOUTH LINE TO AN INTERSECTION WITH THE WEST LINE OF GREENWOOD ROAD; THENCE SOUTHERLY ALONG SAID WEST LINE OF GREENWOOD ROAD TO AN INTERSECTION WITH THE EASTERLY EXTENSION OF THE SOUTHERLY LINE OF EAST LAKE AVENUE; THENCE EASTERLY ALONG SAID EASTERLY EXTENSION AND ALONG SAID SOUTHERLY LINE OF EAST LAKE AVENUE TO AN INTERSECTION WITH THE WEST LINE OF GLENDALE ROAD, SAID INTERSECTION BEING ALSO THE NORTHEAST CORNER OF LOT 74 IN GLENVIEW WESTBROOK UNIT NO. 2, A SUBDIVISION IN THE WEST 1/2 OF THE NORTHEAST 1/4 OF SAID SECTION 33, ACCORDING TO THE PLAT THEREOF RECORDED MAY 14, 1954 AS DOCUMENT NO. 15906506; THENCE SOUTHERLY ALONG SAID WEST LINE OF GLENDALE ROAD TO AN INTERSECTION WITH THE NORTH LINE OF DELL PLACE, A DEDICATED PUBLIC STREET WITHIN THE GLENVIEW WESTBROOK SUBDIVISION; AFORESAID, SAID INTERSECTION BEING THE SOUTHEAST CORNER OF LOT 9 IN SAID GLENVIEW WESTBROOK SUBDIVISION; THENCE WESTERLY ALONG THE NORTH LINE OF DELL PLACE AND ALONG THE SOUTH LINE OF SAID LOT 9 TO AN INTERSECTION WITH THE NORTHERLY EXTENSION OF THE EAST LINE OF LOT 7 IN SAID GLENVIEW WESTBROOK SUBDIVISION; THENCE SOUTHERLY ALONG SAID NORTHERLY EXTENSION AND ALONG THE EAST LINE OF SAID LOT 7 TO THE EAST LINE OF BEAVER CREEK, COOK COUNTY, ILLINOIS.

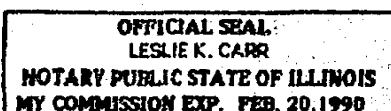
