

AFFIDAVIT

WHEREAS, THE Village of Northbrook did, by Ordinance No. 89-10 dated March 14, 1989, voluntarily annex the following described contiguous territory in accordance with Article 7, Division 1, Section 1 and Division 1, Section 8 of the Illinois Municipal Code:

That part of the West Half of the Southwest Quarter of the Southwest Quarter of Section 5, Township 42 North, Range 12, East of the Third Principal Meridian, described as follows: Commencing at the Southwest corner of said Section 5; thence running East along the South line of said Section 5, also being the centerline of Dundee Road, 28 1/4 Rods; thence North on a line parallel with the West line of said Section 80 Rods more or less to the North line of the Southwest Quarter of the Southwest Quarter of said Section; thence West on a line parallel to the South line of said Section 28 1/4 Rods to the West line of said Section; thence South along the West line of said Section to the place of beginning, (excepting therefrom that part of the West Half of the Southwest Quarter of the Southwest Quarter of Section 5 aforesaid lying North of a line parallel with the South line of Section 5 drawn through a point on the West line of Section 5, 550.00 feet North of the Southwest corner thereof) all in Cook County, Illinois (PRE Nos. 04-05-302-004/014)

all of which territory is not within the corporate limits of any municipality and is contiguous to the Village of Northbrook, Illinois.

WHEREAS, such territory was previously unincorporated and a part of the Northbrook Rural Fire Protection District; and

WHEREAS, Article 7, Division 1, Section 1 of the Illinois Municipal Code requires notification of proposed annexation to be provided to the applicable Fire Protection District;

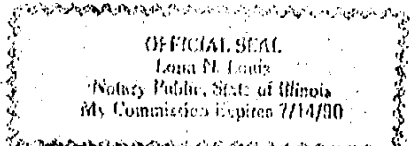
