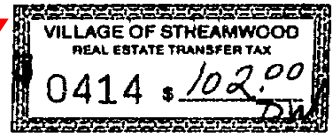


# UNOFFICIAL COPY Warranty Deed

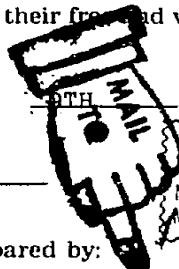
