FIRST AMENDMENT TO SHORT FORM LEASE

WHEREAS, the "Lease" referred to in said Short Form Lease has been amended pursuant to a First Amendment to Lease Agreement of even date herewith, entered into by and between Lessor and Lessee; and

WHEREAS, the parties hereto desire to amend said Short Form Lease so that it will conform to First Amendment to Lease Agreement; and

WHEREAS, at the time said Short Form Lease was entered into, McWil Leasing was the beneficiary under a certain Trust Agreement (the "Trust") dated Cotober 5, 1978 and known as Trust No. 2487 for which Ford City Bank and Trust Company, now known as Cole Taylor Bank/Ford City, the "Trustee") was acting as Trustee; and

WHEREAS, the Trustee was at the time of execution of the Short Form Lease, and continues to be, the record title holder of the real property described in Exhibit A to caid Short Form Lease and of the real property described in Exhibit A, attached hereto; and

WHEREAS, McWil Leasing entered into the Lease and the Short Form Lease, solely as beneficiary under the Trust and reither McWil Leasing nor Graymorre Leasing (the current beneficiary under the Trust) have any interest in the title to the real estate described in the preceding paragraph.

NOW THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, receipt of which is hereby acknowledged, it is hereby agreed as follows:

- 1. The term of said Short Form Lease is hereby amended to provide for a commencement date of July 17, 1979 and a termination date of July 31, 1999.
- 2. Exhibit A to the Short Form Lease (containing the legal description of the leased premises) is deleted and replaced with Exhibit A which is attached hereto and made a part thereof.
- 7. A new sentence is added to the Short Form Lease which provides as follows: "Under the Lease, during the term of the Lease (excluding the first twelve months of the term) and during the five year extension of the term (if Lessee elects to so extend the term), Lessee has a right of first refusal to purchase the real estate described in Exhibit A to the First Amendment to Short Form Lease (i.e., this instrument)."
- 4. Except as amended by the foregoing provisions, the Short Form Lease shall remain unmodified and in full force and effect.
