SAID INDEBTEDNESS, LIENS AND LAND BEING DESCRIBED AS FOLLOWS:

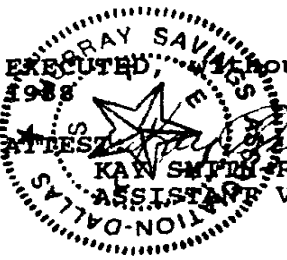

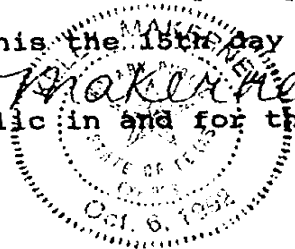
