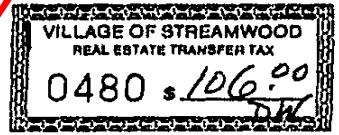

## TRUSTEE'S DEED

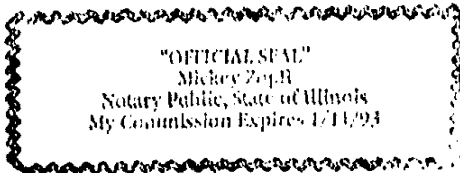

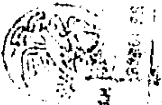
