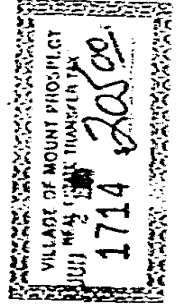
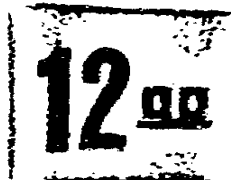
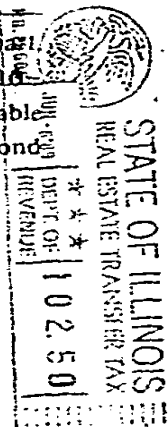

PATRICIA A. KESSE, his wife, as joint tenants with right of survivorship, not as tenants in common.

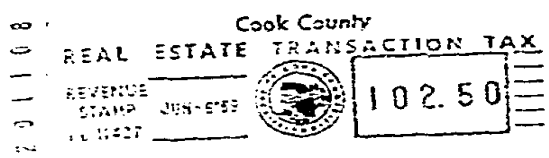
