Section 2: The territory described in Section 2 hereinabove is not within the corporate limits of any municipality and is contiguous to the present Village limits of the Village of Glenview.

Section 4: The Clerk of the Village of Glenview is hereby authorized and directed to record with the Recorder of Deeds of Cook County, Illinois, a certified copy of this Ordinance together with an accurate map of the territory annexed, and a document of annexation shall be filed with the County Clerk and the County Election Authority.

Section 5: Proper notice to the Trustees of the Glenbrook Fire Protection District has been served in compliance with the provisions of Chapter 24, Section 7-1-1, Illinois Revised Statutes (1987). Proper notice has also been duly served on the Trustees of Northfield Township and the Highway Commissioner of Northfield Township. An affidavit with respect to notice to the Trustees of the Glenbrook Fire Protection District shall be recorded in accordance with statutory requirement.

Section 6: Proper notice in accordance with the statutory requirement was published in a newspaper of general circula-

tion within the territory to be annexed stating that annexation of the territory described in the notice was contemplated under Section 7-1-13 of the Illinois Municipal Code.

Section 7: Every section and provision of this Ordinance shall be separable, and the invalidity of any portion of this Ordinance shall not affect the validity of any other portion hereof.

Section 8: This Ordinance shall take full effect upon its passage and approval according to law.

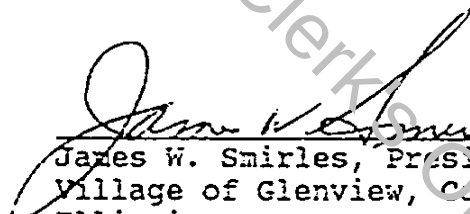
