Upon the foreclosure and sale of the mortgaged property, or any part thereof, the proceeds of such and or sales shall be applied as follows: First, to reasonable attorne, Tees, court costs and expenses, outlays for documentary stamps, cost of procuring title certificates, continuing abstracts, title services or examinations reasonably necessary or proper; and next, to the payment of any and all advances made by Mortgagee, with interest thereon as hereinabove provided; next, to the payment of the onlance of the indebtedness evidenced by the note secured hereby, with interest thereon as therein provided; and any surplus thereat er shall be paid to Mortgagor; provided that in the event the net proceeds of such sale or sales shall not be sufficient to pay in full the indeptedness hereby seemed, Mortgagor hereby promises and agrees to pay any deficiency thereon on demand.

VIII.
