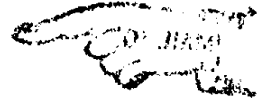


# UNOFFICIAL COPY

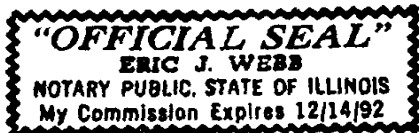
