

**AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP
MADE BY KINGSTON CONDOMINIUM ASSOCIATION**


Pursuant to Section 331 of the Condominium Property Act, Chapter 30, Ill. Rev. Stat., Section 317 (1983), the Board of Managers does hereby approve and amend the Declaration as shown on the attached amended plat so as to cause the portion of the common elements designated therein to become attached to and a part of Unit 1931-S. The plat showing the change is attached hereto and incorporated into this Amendment.




