9. Successor and Assigns Bound; Joint and Several Liability; Co-Signers. The covenants and agreements of this Morigage shall bind and benefit the successors and assigns of Lender and Borrower, subject to the provisions of paragraph 12. Borrower's covenants and agreements shall be joint and several. Any Borrower who co-signs this Mortgage but does not execute the Agreement, (a) is co-signing this Mortgage only to mortgage, grant and convey that Borrower's interest in the property under the terms of this Mortgage; (b) is not personally obligated to pay the sums secured by this Mortgage; and (c) agrees that Lender and any other Borrower may agree to extend, modify, forebear or make any accommodations with regard to the terms of this Mortgage or the Agreement without that Borrower's consent.

10. 12. Transfer of the Property. If all or any part of the property, or an interest therein is sold or transferred by Borrower or if the beneficial interest or any part thereof if any land trust holding title to the property is assigned, sold or transferred, or if the Borrower or the title holding trust enters inc. Articles of Agreement for Deed or any agreement for installment sale of the property or the beneficial interest in the title boring land trust, without Lender's prior written consent, excluding (a) the creation of a purchase money security interest for horsehold appliances, (b) a transfer by devise, descent or by operation of law upon the death of a joint tenant, or (c) the grant of any Laschold interest of three (3) years or less not containing an option to purchase, Lender may, at Lender's option, declare all suits secured by the Mortgage to be immediately due and payable.

13. Acceleration; Remedies. Upon a Default by Borrower under this Mortgage, Lender, at its option, may require
