

Excerpts From Internal Revenue Cruse :

Sec. 6321. Lien For Taxes.

If any person hable to pay any tax neglects or retuses to pay the same after demand, the amount (including any interast, additional amount, addition to tax, or essectable penalty tiver with any costs that may eccrus in addition thereto) sha'l be a lien th favor of the United States upon all property and rights to preparty, whether rest or personal, belonging to such person

Sec. 6322. Period Of Lien.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Intersets, Mechanic's Lienors, And Judgment Lief Creditors. - The Ren Imposed by section 621 shall not be valid as against any purchaser, holder of a security Interest, mechanic's flenor, or judgment lien craditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

m Place For Filing Notice; Form.-

(1) Place For Filing - The notice referred to in subsection (a) shall be filled -

(A) Under State Laws

(i) Real Property - in the case of real property, in one office within the State for the county, or other governm subdivisions, as designated by the laws of sich State, in which the property subject to the lien is situated; and

(iii) Personal Property - in the case of personal MODERLY, inhether language or intergene, to one office within the State for the county or other governmental subdivision, as designated by the laws of such State. stich the property subject to the fren is situated:

(B) With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to Hen is situated, whenever the State has ACT by law designated one office which meets the requirements of ubbaragraph (A) or

(3) Required Reffling Period. — in the case of any notice of ijen, the term "required refitting period" means -(A) the one-year period ending 30 days after the expiration of 6 years after the date of the assessment of the tax, and (8) the one-year period ending with the expiration of 6 years after the close of the preceding required reffling period for such notice of lien.

Sec. 6325. 1 Release Of Lien Or : Discharge Of Property.

eee Of Lien. — Subject to such regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lian imposed with respect to any internal revenue tax not later than 30 days after the day on

(1) Liability Satisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become legally unenforceable; or

(2) Bend Accepted - There is furnished to the Secretary and scapted by him a bond that is conditioned upon the payment of amount assessed, together with all interest in respect thereof within the time prescribed by law (including any extension of eval time), and that is in accordance with such requirements raising to terms, conditions, and form of the bond and sureties therein, as may be specified by such regulations.

(2) Disclosure at amount of outstanding lies. - If a notice of lien has been filed pursuant to section \$323(f), the amount of the outstanding obligation secured by such lien may be disclosed to any person who furnishes satisfactory written evidence that he has a right in the property subject to such lien or intenda to obtain a right in such property.
