AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE ROLLING MEADOWS PARK DISTRICT, COOK COUNTY, ILLINOIS

WHEREAS, on December 27, 1988, the Secretary of the Rolling Meadows Park District did receive certain petitions signed in counterpart describing a certain territory as follows:

NOW, THEREFORE, BE IT ORDAINED by the Board of Park Commissioners of the Rolling Meadows Park District that:

SECTION ONE: The provisions of the preamble hereinbefore set forth are hereby restated herein as though fully set forth herein.

SECTION TWO: The following described territory be and the same is hereby annexed to the Rolling Meadows Park District, Cook County, Illinois, pursuant to and under the authority contained in Paragraph 3-1 of Chapter 105 of the Illinois Revised Statutes:

SECTION FIVE: If in, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such determination shall not diffect the validity of any remaining portion of this Ordinance.

SECTION SIX: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
