- 1. PAYMENT OF PRINCIPAL AND INTEREST; PREPAYMENT AND LATE CHARGES. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.
- 2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a written waiver by Lender, Borrower shall pay to Lender on the day monthly payments are due under the Note, until the Note is paid in full, a sum ("Funds") equal to one-twelfth of: (a) yearly taxes and assessments which may attain priority over this Security Instrument; (b) yearly leasehold payments or ground rents on the Property, if any; (c) yearly hazard insurance premiums; and (d) yearly mortgage insurance premiums, if any. NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follows:

- 19. ACCELERATION: REMEDIES. Lender shall give notice to Borrower prior to acceleration following Sorrower's breach of any covenant or agreement in this Security Instrument (but not prior to acceleration under paragraphs 15 and 17 unless applicable law provides otherwise). A. USE OF PROPERTY; COMPLIANCE WITH LAW. Borrower shall not seek, agree to or make a change in the use of the Property or its zoning classification, unless Lender has agreed in writing to the change. Borrower shall comply with all laws, ordinances, regulations and requirements of any governmental body applicable to the Property.

B. SUBORDINATE LIENS. Except as permitted by federal law, Borrower shall not allow any lien inferior to the Security Instrument to be perfected against the Property without Lender's prior written permission.

C. RENT LOSS REPURANCE. Borrower shall maintain insurance against rent toss in addition to the other hazards for which insurance is required by Uniform Covenant 5.

D. "BORROWER'S RICHT TO REINSTATE" DELETED. Uniform Covenant 18 is deleted.

E. ASSIGNMENT OF LEASES. Upon Lender's request, Borrower shall assign to Lender all leases of the Property and all security deposits made in connection with leases of the Property. Upon the assignment, Lender shall have the right to modify, extend or terminate the exacting leases and to execute new leases, in Lender's sole discretion. As used in this paragraph E, the word "lease" shall rean "sublease" if the Security Instrument is on a leasehold.

F. ASSIGNMENT OF RENTS. Bor ower unconditionally assigns and transfers to Lender all the rents and revenues of the Property. Borrower authorizes Lender or Lender's agents to collect the rents and revenues and hereby directs each tenant of the Property to pay the rents to Lender's negents. However, prior to Lender's Notice to Borrower of Borrower's breach of any covenant or agreement in in Security Instrument, Borrower shall collect and receive all rents and revenues of the Property as trustee for the benefit of Lender and Borrower. This assignment of rents constitutes an absolute assignment and not an assignment for additional security only.

If Lender gives notice of breach to Borrower: (i) all rents received by Borrower shall be held by borrower as trusted for benefit of Lender only, to be applied to the sums securer by the Security Instrument; (ii) Lender shall be entitled to collect and receive all of the rents of the Property; and (ii) each tenant of the Property shall pay all rents due and unpaid to Lender or Lender's agent on Lender's written demand to the content.

Borrower has not executed any prior easignment of the rents and has not and will not perform any act that would prevent Lender from exercising its rights under this paragraph F.

Lender shall not be required to enter upon, take control of or maintain the Property before or after giving notice of breach to Borrower. However, Lender or a judicially appointed receiver may to start any time there is a breach. Any application of rents shall not cure or waive any default or invalidate any other wight or remody of Lender. This assignment of rents of the Property shall terminate when the debt secured by the Security Instrument is paid in full.
