Borrower will continue to be obligated under the Note and Security Instrument unless Lender releases Borrower in writing.
- C. APPLICABILITY. Larger is bound by these conditions and terms, as follows:
 - 1. This Assumption Pile applies only to the first transfer of the Property by Borrower and not to a foreclosure sale;
 - 2. Purchaser must be an individual, not a partnership, corporation or other entity.
 - 3. Purchaser must meet hencor's credit underwriting standards for the type of loan being assumed as if Lender were making a new loan to purchaser;
 - 4. Purebaser shall assume only the before due on the Note at the time of assumption for the term remaining on the Note;
 - If applicable, Borrower's private marging resurance coverage must be transferred to the purchaser in writing, unlies waived by Lender; and
 - 6. Londor must reasonably determine that Londor's security will not be impaired by the loan assumption.
- D. ASSUMPTION INTEREST RATE. Lander has the right to courge the Purchaser a different interest rate under the Note than was paid by Borrowers. Lender will charge an interest rate which is the greater of one percent (1%) lower than the interest rate being charged on Lander's most comparable product at the time of assumption, or the Note interest rate; provided, however, that in no event shall the new interest rate exceed 25% per annum.
- E. ADDITIONAL CHARGES. In addition to adjusting the Note interest of a Londor may charge an amount up to one percent (197) of the current Note behance and its normal langelosing costs, except the central real estate appraisal.
