

THIS INDENTURE, made this 2nd day of March,
1967, between CENTRAL HOTEL COMPANY, a corporation created and
existing under and by virtue of the laws of the State of Illinois
and duly authorized to transact business in the State of Illinois,
and PICK-HARRISON CORPORATION, a corporation created and existing
under and by virtue of the laws of the State of Illinois, and duly
authorized to transact business in the State of Illinois,
collectively the party of the first part, and CHICAGO TITLE AND
TRUST COMPANY, AS TRUSTEE UNDER THE PROVISIONS OF A TRUST
AGREEMENT DATED MARCH 25, 1967 AND KNOWN AS TRUST NUMBER 1089673,
111 West Washington Street, Chicago, Illinois, 60602, trustee and
party of the second part, WITNESSETH, that the party of the first
part, for and in consideration of the sum of Ten and 00/100
(\$10.00) Dollars and other good and valuable consideration in hand
paid by the party of the second part, the receipt whereof is
hereby acknowledged, and pursuant to authority of the Boards of
Directors of said corporations, by these presents do REMISE,
RELEASE, ALLEGE AND CONVEY unto the party of the second part, and
to its heirs and assigns, FOREVER, all the following described
land, situated in the County of Cook and State of Illinois known
