- 5. Any change of registered agent must be by resolution adopted by the board of directors. This statement must then be signed by the Fresident (or vice-president) and by the Secretary (or an assistant secretary).
- The registered agent may report a change of the registered office of the corporation for which he 6. Olyny Clark's Office or she is registered agent. When the agent reports such a change, this statement must be signed by the registered agent.
