ORDER

THIS MATTER COMING TO BE HEARD UPON PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT AGAINST ABRAHAM SOVA, 307 SOUTH AND SIDNEY WEINSCHNEIDER AND THE COURTS FINDING THAT THAT THERE IS NO GENUINE ISSUE AS TO ANY MATERIAL FACT WITH RESPECT TO SAID PARTIES AND THE JUDGMENT ENTERED HEREIN AND THAT THERE IS NO REASON TO DELAY APPEAL OR ENFORCEMENT OF THE JUDGMENT ENTERED THEREIN AND THE COURTS BEING ADVISED IN THE PREMISES:

- 1) JUDGMENT IS HEREBY ENTERED IN FAVOR OF PLAINTIFF AND AGAINST DEFENDANTS ABRAHAM SOVA, 307 SOUTH AND SIDNEY WEINSCHNEIDER JOINTLY AND SEPARATELY FOR \$550,000 FOR THE PRINCIPAL AMOUNT DUE UNDER THE SUBJECT NOTE AND GUARANTY AND FOR \$41,370.20 FOR THE INTEREST DUE UNDER THE SUBJECT NOTE AND GUARANTY AS OF THIS DATE FOR A TOTAL JUDGMENT OF \$591,370.20
- 2) PURSUANT TO SUPREME COURT RULE 304(b), THE COURTS EXPRESSLY FINDS THAT THERE IS NO JUST REASON FOR DELAYING THE ENFORCEMENT OR APPEAL OF THE ABOVE JUDGMENT
- 3) PLAINTIFF'S CLAIM FOR ATTORNEYS FEES IS CONTINUED, SUBJECT TO AGREEMENT
- 4) ANY JUDGMENT TO PLAINTIFF INCLUDING COSTS OF COLLECTION WITH THE FORECLOSURE CASE REGARDING THE SUBJECT NOTE AND GUARANTY SHALL BE CREDITED AGAINST THE JUDGMENT.
