- 2. APPLICATION OF PAYMENT. The monthly payment will be made by means of automatic funds transfer. The minimum payment, as shown on your statement, will be transferred on the 10th of each month. Payments will be applied in the following order: 1) Accrued finance charges; 2) Late charges, 1f any; 3) Annual service fee and/or other charges, if any; 4) Principal reduction.
- 3. CHARGES; LIENS. Borrower shall promptly pay all obligations secured by a prior martgage or a prior trust deed effecting the property. In addition, Borrower shall promptly pay all real estate taxes and assessments attributable to the property. Borrower shall promptly discharge any lien which has priority over this mortgage.
- 4. HAZARD INSURANCE. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire and herards included within the term "extended coverage," and such other hazards as Lender may require and in such amounts and for such periods as Lender may require.

The incurance Carrier providing the insurance shall be chosen by the Borrower subject to approval by Lender; provided that such approval shall not be unreasonably withheld. All premiums on insurance policies shall be paid by Borrower when due.

All insurance rolicies and renewals thereof shall include a standard mortgage clause in favor of Lender. Lender shall have the right to hold the policies and renewals thereof. In the event of loss, Borrower shall give prompt rotice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower.

Unless Lender and Surrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged. Borrower shall faithfully and fully comply with and abide by every term, covenant and condition of any superior mortgage or mortgages presently encumbering the Property. A default or delinquency under any superior mortgage or mortgages shall automatically and immediately constitute a default under this Mortgage. Lender is expressly authorized, at its option, to advance all sums necessary to keep any superior mortgage or mortgages in good standing, and all sums so advanced, together with interest, shall be subject to the provisions of this covenant. - 10. FORBEARANCE BY LENDER NOT A WAIVER. Any forbearance by Lender in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shell not be a waiver of or preclude the exercise of any such right or remedy.
- 11. SUCCESSORS AND ASSIGNS BOUND; JOINT AND SEVERAL LIABILITY; CO-SIGNERS. - Except for any notice required under applicable law to be given in another manner, (a) any notice to Borrower provided for in this Mortgage shall be given by mailing such notice by first class mail addressed to Borrower at the Property Address or at such other address as Borrower may designate by notice to Lender as provided herein, and (b) any notice to Lender shall be given by first class mail, to Lender's address stated herein or to such other address as Lender may designate by notice to Borrower as provided herein. Any notice provided for in this Mortgage shall be deemed to have been given to Borrower or Lender when given in this manner designated.
- 13. GOVERNING LAWS; SEVERABILITY. The state and local laws applicable to this Mortgage shall be the laws of the jurisdiction in which the Property is located. The foregoing sentence shall not limit the applicability of Federal law to this Mortgage. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of this Mortgage and the Note are declared to be severable. As used herein, "costs", "expenses" and "attorneys fees" include all sums to the extent not prohibited by applicable law or limited herein.
