SUBORDINATION AND ATTORNMENT AGREEMENT

THIS SUBORDINATION AND ATTORNMENT AGREEMENT ("Agreement"), made as of this 15th day of June, 1989, executed by Mercury Finance Company of Illinois and Mercury Finance Company an Illinois corporation, having its principal office at 40 Skokie Boulevard, Suite 200, Northbrook, Illinois, 60062 ("Tenant") and for the benefit of BERSKSHIRE LIFE INSURANCE COMPANY, having an office at 700 South Street, Fittsfield, Massachusetts, 01201 ("Mortgagee").

WITNESSETH:

WHEREAS, American National Bank and Trust Company of Chicago as trustee under trust agreement dated November 17, 1987 and known as trust number 104043-09 ("Landlord") and Tenant have entered into a lease (the "Lease") dated as of February 24, 1989 of certain premises (the "Premises") situated in Chicago, Illinois, which are a runt of that certain parcel of real property (the "Project") legally described in Exhibit A attached hereto and made a part hereof; and

WHEREAS, in conjunction with a certain loan from Mortgagee to Landlord, Landlord is about to make, execute and deliver to Mortgagee a certain promissory rote (the "Note") secured by a Mortgage and Security Agreement (the "Mortgage") creating a lien on the Project; and

WHEREAS, the Lease will be assigned of landlord to Mortgagee as further security for the Note.

NOW, THEREFORE, in consideration of Ten and ho/100 dollars (\$10.00) in hand paid and other good and valuable consideration, the receipt and sufficiency whereof is hereby cknowledged, Tenant, intending to be legally bound hereby, coverants and agrees as follows:

- 1. The Lease shall be subject and subordinate to the lien of the Mortgage and to all the terms, conditions and provisions thereof, to all advances made or to be made thereunder, and any renewals, extensions, modifications or replacements thereof.
- If Mortgagee or any successor or assignee of Mortgagee shall succeed to the rights of Landlord under the bease, whether through possession, termination or cancellation of the Lease, surrender, assignment, judicial action, sublettings, foreclosure action or delivery of a deed or otherwise. Tenant will attorn to and recognize Mortgagee or such successor-landlord as Tenant's landlord,

- 3. Mortgagee and any successor or assignee of Mortgagee shall not be liable for any default by Landlord under the Lease occurring prior to the date on which Mortgagee shall have succeeded to the right of Landlord under the Lease.
- 4. Tenant will not terminate or cancel the Lease or the term thereof by reason of a default by Landlord thereunder unless and until Tenant has given written notice of the default at the same time Landlord is notified thereof, at the addresses stated below or such other address designated in writing to Tenant, and has affired Mortgagee such time as under the Lease is granted to Landlord to remedy the particular default. For the purposes of this paragraph 4, notice shall be provided to:

- 5. (a) Tenant will not ρa_{ij} an installment of rent or any part thereof more than thirty (.0) days prior to the due date of such installment.
- (b) After notice from Mortgagee to Tenant at the Premises, Tenant will pay to Mortgagee, or to such person or firm designated by Mortgagee, or to such person or firm designated by Mortgagee, all rentals and other monies due and to become due Landlord under the Lease.
- (c) After the date hereof, no amendment or modification of the Lease entered into between Tonant and Landlord, which might materially and adversely affect the security lien of Nortgagee, shall be valid as against Mongagee, its successors and assigns, unless Mortgagee has approved such amendment or modification in writing.
- 6. This Agreement shall continue in effect until payment in full of all sums due from Landlord to Mortgagee under the Note and the Mortgage.
- 7. This Agreement shall inure to the benefit of and be binding upon the Tenant and its heirs, executors, distributees, administrators, legal representatives, successors and assigns and may not be modified orally or by any course of conduct other than
