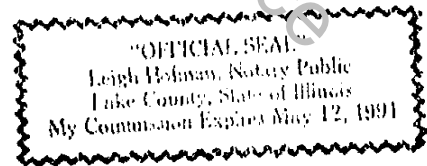

MORTGAGE

EXTENSION AGREEMENT

DATED July 23, 1989 UNDER TRUST NO. 3187-HP

All the terms, provisions, stipulations, covenants and conditions to be performed by NBD TRUST COMPANY OF ILLINOIS Successor Trustee to NBD Highland Park Bank, N.A. formerly known as First National Bank of Highland Park, are undertaken by it solely as Trustee as aforesaid, and not individually, and no personal liability shall be asserted or be enforceable against NBD TRUST COMPANY OF ILLINOIS Successor Trustee to NBD Highland Park Bank, N.A. formerly known as First National Bank of Highland Park, by reason of anything contained in said instrument, or in any previously executed document, whether or not executed by said NBD TRUST COMPANY OF ILLINOIS Successor Trustee to NBD Highland Park Bank, N.A. formerly known as First National Bank of Highland Park, either individually or as Trustee as aforesaid, relating to the subject matter of the attached agreement, all such personal liability, if any, being expressly waived by every person now or hereafter claiming any right or security hereunder. No duty shall rest upon NBD TRUST COMPANY OF ILLINOIS Successor Trustee to NBD Highland Park Bank, N.A. formerly known as First National Bank of Highland Park, personally or as said Trustee, to sequester the rents, issues and profits arising from the sale or other disposition thereof, but so far as said Trustee, and its successors and said NBD TRUST COMPANY OF ILLINOIS Successor Trustee to NBD Highland Park Bank, N.A. formerly known as First National Bank of Highland Park, personally are concerned, the legal holder or holders of this instrument and the owner or owners of any indebtedness accruing hereunder shall look solely to the mortgaged real estate for the payment thereof, by enforcement to the lien heretofore created in the manner provided therefore and as provided in said note or by action to enforce the personal liability of the guarantor, if any.
