The Village of Hanover Park, Illinois, an Illinois Municipal Corporation, pursuant to the provisions of Section 11-20-7 of the Illinois Municipal Code (Chapter 24, Illinois Revised Statutes 1979), hereby files Notice of Lien in its favor in the amount of \$75.00 plus filing fees and interest at 10% per year against the following described real estate: Lot 112 in Hanover Park Terrace, being a subdivision in the west half of the northwest quarter of section 36, township 41 north, range 9 east of the third principle meridian in the Village of Hanover Park, Cook County, Illinois.

Commonly known as 6861 Hickory, Hanover Park, Illinois.
Property Index No. 06-36-119-032.

That sections 14-70 through 14-75 of the Municipal Code of Hanover Park requires the owner or occupant of any property within the Village to cut all weeds on the property exceeding eight inches in height after notice or the Village shall cut the weeds and place a lien on the property.

That on May 31, 1989, the owners of the above described property were notified in writing in accordance with the above mentioned ordinance provisions, but that said owners neglected and/or refused to cut the weeds.

That on June 28, 1989, the Village of Hanover Park, Illinois, caused said weeds to be cut, removed, and destroyed and the reasonable cost and expense incurred for the work was \$75.00, and that said sum remains unpaid.
