#### WITNESSETH:

WHEREAS, the Porrower and the Bank have executed that certain Home Equity Line of Credit Agreement and Disclosure Statement dated June 11, 1938 (the "Credit Agreement") pursuant to which the Bank agreed to establish a Home Equity Line (defined therein) for the benefit of Borrower in the maximum amount of \$60,000.00 bearing interest at an Annual Percentage Rate equal to 1.50% in excess of the Prime Rate (defined therein) for a period with an Initial Expiration Date (defined therein) of June 11, 1993; and

WHEREAS, in order to secure to the Bank the repayment of the indebtedness incurred pursuant to the Credit Agreement, the Borrower executed and delivered to the Bank that certain Home Equity Line of Credit Mortgage dated June 11. 19.88 (the "Mortgage") pursuant to which the Borrower mortgaged, granted and conveyed to the Bank certain real property described therein and on Exhibit A attached hereto; and

WHEREAS, the Borrower has requested that the Bank change certain terms of the Home Equity Line contained in the Credit Acreement and/or the Mortgage; and

WHEREAS, the Bank and the Borrower have agreed to change such terms of the Home Equity Line and desire to amend the Credit Agreement and the Mortgage to reflect such changes.
