DECLARATION OF PLANNING

THE K. F. BORN, Inc., a Illinois Corporation, is the legal title holder of certain estate located on South Phillips Avenue, Chicago, Illinois legally described in attached "Exhibit A".

At #233, The Development consists of certain lots within the aforesaid area of real estate as hereinafter more particularly described which are intended as the sites for development and construction of five (5) dwelling buildings, each building consisting of five (5) attached single family residences.

Now, therefore, K. F. Born, does hereby make the following rights, covenants, agreements, burdens, uses and priviledges, and do enact at all times hereafter among the several owners, successors or assigns of the said parts of real estate in said instrument described in the same and to the extent herein set forth and that the declarations contained herein shall be binding upon and inure to the benefit of each and every such party in this instrument described:

An easement over, under and across the south fifteen (15) feet of said property is hereby declared and granted for the benefit of the Development; all owners and occupants, and their respective licensees and invitees for the installation and maintenance of a (a) storm and sanitary sewer submain connecting the Development to the storm and sanitary sewer maintained by the City of Chicago and (b) water submain connecting the Development to the water main maintained by the City of Chicago; it being understood and agreed that the obligation to install and maintain said submain shall be borne by the K. F. Development prior to the sale of said home and thereafter, by the owner, and that no action thereon shall, subject to the aforesaid governmental or utility rule or regulation, inure to the benefit of the Development.
