On June 1, 1989, at 9:30 a.m., the above-entitled matter came on for hearing, at a Special Term of the above-named Court, upon a Petition of the Plaintiff for an Order confirming the foreclosure sale, and on the 1st day of June, 1989, the Court did make and file its Order Confirming Foreclosure Sale, authorizing the Sheriff of St. Louis County to execute and deliver to the purchaser at said sale a Sheriff's Certificate of Sale, and ordering the entry of a Deficiency Judgment for the remainder due the Plaintiff.

Now, pursuant to said Order, a Judgment for said deficiency be and is hereby entered in favor of the Plaintiff, Norwest Bank Minnesota Mesabi, National Association, a National Banking Association, and against Defendant Dennis J. Konecny, in the sum of Three Thousand, Five Hundred Seventy-four and 21/100ths Dollars (\$3,574.21), and that an execution for the deficiency
