PETITION FOR REGISTRATION OF FOREIGN JUDGMENT

NOW COMES Plaintiff, MERRILL LYNCH, PIERCE, FENNER & SMITH, INC. (hereinafter referred to as "MERRILL LYNCH"), a corporation, by its attorneys, CANTWELL & BALONICK, and in support of its Potition for Registration of a Foreign Judgment against Defendant, SOL GREEN, states as follows:

- 1. At the times hereinafter mentioned, the Superior Court for the County of San Diego, State of California, was a court of general jurisdiction, duly created and organized by the laws of that state.
- 2. On or about February 19, 1988, MERRILL LYNCH commenced an action in said court against the Defendant.
- 3. On or about November 14, 1988, Judgment was duly entered by said court in favor of MERRILL LYNCH and against Defendant in the amount of EIGHTY FOUR THOUSAND, NINE HUNDRED FIFTY-FIVE AND 19/100 (\$84,955.19) DOLLARS. A true and correct copy of the Judgment is hereto attached, marked as Exhibit "A" and by this reference made a part hereof.
 - 4. No part of the Judgment has been paid or satisfied.
- 5. Since the entry of Judgment against the Defendant in California, postjudgment interest has accrued on the Judgment at the rate of ten (10%) percent per

annum pursuant to the provisions of §685.010 of the California Code of Civil Procedure.

WHEREFORE, Plaintiff, MERRILL LYNCH, PIERCE, FENNER & SMITH, INC., a corporation, respectfully prays that said Judgment entered by the Superior Court of San Diego County, State of California, be registered as a Foreign Judgment in the Circuit Court of Cook County, Illinois, and that the same become a final Judgment of the Court in which it is registered, binding personally upon the Defendant in accordance with the provisions of the Uniform Enforcement of Foreign Judgments Act; that it be adjudged and decreed that there is now due and owing to MERRILL LYNCH from Defendant, SOL GREEN, the sum of EIGHTY-FOUR THOUSAND, NINE HUNDRED FIFTY-FIVE AND 19/100 (\$84,955.19) DOLLARS together with post-judgment interest thereon and costs of this suit; and that MERRILL LYNCH have such other and further relief as the Court deems appropriate.
