THIS INDENTURE, made August 5 19 89, between
Terry B. Shapiro and Marie L. Shapiro, his wife

herein referred to as "Mortgagors", and

HARRIS BANK WINNETKA, a National Banking Association, organized

and existing under the laws of the United States of America, with its principal office in the Village of Winnetka, County of Cook, State of Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the principal Promissory Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the Principal Sum of (\$67,000.00)

SIXTY SEVEN THOUSAND AND NO/100 DOLLARS, evidenced by one certain Principal Promissory Note of the Mortgagors of even date herewith, made payable to THE ORDER OF BEAKER HARRIS BANK WINNETKA N.A.

and delivered, in and by which said Principal Note the Mortgagors promise to pay the said principal sum

One year after date with interest thereon from date of note until maturity at the rate of P+2.00%* per cent per annum, payable on the 3rd day of November and of interest at each year, all of said principal and interest bearing interest after maturity at the rate of P+3%** per cent per annum, and all of said principal and interest being made payable at such banking house in Winnetka, Illinois, as the holders of the note may, from time to time, in writing appoint and in absence of such appointment, then at the office of HARRIS BANK WINNETKA N.A. in said City,

NOW, THEREFORE, the Mortgagors to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the City of Chicago COUNTY OF COOK AND STATE OF ILLINOIS, to wit:

Unit 205 together with their undivided percentage interest in the common elements in 1147 West Ohio Street Condominium as delineated and defined in the declaration recorded as document number 26419212, in the northeast 1/4 of section 8, township 39 north, range 14, east of the third principal meridian, in Cook County, Illinois.


which, with the property hereinafter described, is referred to herein as the "premises,"

All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by the mortgagors or their successors or assigns shall be considered as constituting part of the real estate.


