ORDINANCE NO. 3016

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO
THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

WHEREAS, the corporate authorities of the Village of Glenview, have determined that annexation of certain territory in Cook County, Illinois, hereinafter described, is in the public interest and in the best interests of the Village of Glenview, and will promote the public health, safety and welfare of the Village and its residents; and

WHEREAS, the corporate authorities of the Village of Glenview, a home rule municipality, find that the following described territory is unincorporated territory containing less than 60 acres and is wholly bounded by the Village of Glenview.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that

Section 1: The facts and statements contained in the preamble to this ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

Section 2: The unincorporated territory, containing less than 60 acres and wholly bounded by the Village of Glenview, and is legally described as follows:

Beginning at the point of intersection of the west R.O.W. line of Landwehr Road with the south line of the northwest 1/4 of Section 20, Township 42 north, range 12; Thence north along the west R.O.W. line of Landwehr Road to the intersection of said west R.O.W. line of Landwehr Road with the south line of lot 5 in the Brown's Resubdivision of part of lots 3 and 25 of Brookdale Manor Unit 2, recorded September 8, 1983 as Document No. 26768884; Thence west along the south line of lot 5 in the aforementioned Brown's resubdivision to the intersection of said south line of lot 5 with the east line of lot 4 in the aforementioned Brown's Resubdivision; Thence south along the east line of lot 4 in the aforementioned Brown's Resubdivision and that line extended south to the south R.O.W. line of Brookdale Lane; Thence Easterly along the south R.O.W. line of Brookdale Lane to the intersection of said south R.O.W. line with the east line of lot 1 in the aforementioned Brown's Resubdivision; Thence south along the east line of Lot 1 in the aforementioned Brown's Resubdivision to the intersection of said east line of lot 1 with the south line of the northwest 1/4 of Section 20, Township 42 north, Range 12; Thence east along the south line of the east 1/2 of the northwest 1/4 of Section 20, Township 42 north, Range 12 to the place of beginning, all in the east 1/2 of the northwest 1/4 of Section 20, Township 42 north, Range 12, East of the Third Principal Meridian in Cook County, Illinois.

be and the same is hereby annexed to the Village of Glenview, Cook County, Illinois, pursuant to the provisions of Section 7-1-13 of the Illinois Municipal Code.

Section 4: This ordinance shall take full effect upon its passage and approval according to law.




