TRUST DEED

THIS INDENTURE, made AUGUST 17TH 19 89, between CHUCHAI GOSRISIRIKUL AND

VANTANEE GOSRISIRIKUL, IN JOINT TENANCY herein referred to as "Mortgagors," and Security Pacific Financial Services, Inc. XXXXXXXX A Delaware corporation, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder being herein referred to as Holder of the Note, in the principal sum of \$40001.56
