AGREED ORDER

This matter coming to be heard for prove-up hearing on Plaintiff's Complaint, Defendants previously having been held in default, the court being advised of a settlement reached between the parties, and being otherwise fully advised in the premises, does order as follows:
IT IS ORDERED THAT:

1. Plaintiff Elk Grove Graphics, Inc. is hereby awarded judgment by agreement of the parties in the sum of \$7,277.19, inclusive of costs and interest against Defendants The Phoenix Organization and Alan H. Israel.
2. Defendants shall pay to Plaintiff the sum of \$300.00 per month beginning September 1, 1989, and on the first day of each month thereafter until the judgment sum is paid in full.
3. So long as Defendants continue to make the aforesaid monthly payments, Plaintiff agrees to refrain from enforcing the judgment award through garnishment, levy, citation and the like. However, should Defendant fail to make a scheduled monthly payment when due, and should said delinquency continue for a period of seven (7) days following the payment due date, Plaintiff shall then be free to enforce the judgment award through all lawful means.
