That the Claimant supplied materials to the value of \$3,678.09.

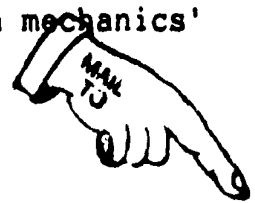
That the balance due and owing the Claimant is the sum of \$3,678.09, for which amount Claimant hereby claims a mechanics' lien on said premises, land, and improvements.

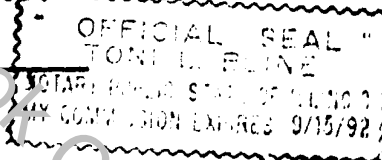
