STATEMENT OF CLAIM FOR STATUTORY LIEN

The Claimant, CITY OF CHICAGO, a Municipal Corporation, by virtue of the authority granted by Chapter 24, Section 11-126-4, of the Illinois Revised Statutes (1987) and Chapter 185 and 185.1 of the Municipal Code of the City of Chicago hereby files its claim for statutory lien against the following premises commonly known as 6221 S. Greenwood and legally described as:

The North 15 feet of Lot 14 and the South 33 feet of Lot 15 in Block 11 in Charles Busby's Subdivision of the South 1/2 (except 2 1/2 acres) of the Southwest 1/4 of Section 14, Township 38 North, Range 14, East of the Third Principal Meridian (commonly known as 6219-21 South Greenwood Avenue, in the City of Chicago, County of Cook, State of Illinois).

Title to the above described property now appears in the name of Sanford and Marquette Blackwell of Cook County, Illinois, but the lien is absolute as to all parties of interest.

Peter E. Pala, Acting Superintendent of Water Collection, being first duly sworn, deposes and states that he has examined the records of the Department of Water and has knowledge of the following:

1. That water was furnished by the City.
2. That said water service was and continues to be provided to the following premises commonly known as 6221 S. Greenwood and legally described as:

The North 15 feet of Lot 14 and the South 33 feet of Lot 15 in Block 11 in Charles Pusby's Subdivision of the South 1/2 (except 2 1/2 acres) of the Southwest 1/4 of Section 14, Township 38 North, Range 14, East of the Third Principal Meridian (commonly known as 6219-21 South Greenwood Avenue, in the City of Chicago, County of Cook, State of Illinois).

3. That the quantity of water furnished was approximately 195,000 cubic feet.

4. That the above water service was furnished by Claimant at the rate as provided in Chapter 185 of the Municipal Code of the City of Chicago.

5. That the amount of money currently due for water service therefore is \$1,411.06.

6. That sewer service and use of the sewerage system was furnished by the Claimant to the said premises.

7. That the above sewer service and use of the sewerage system was furnished at the rate as provided in Chapter 185.1 of the Municipal Code of the City of Chicago.

8. That the amount currently due for sewer service therefore is \$974.68.


9. That the total currently due therefore is \$2,385.74.

10. That the above amounts became delinquent on July 24, 1989.

11. That notice of filing this claim was mailed to the "owner or owners and party or parties" interested in the premises located at 6221 S. Greenwood on August 9, 1989.

12. That less than four months have elapsed since the above amount became delinquent.

13. That as of this date said owner(s), titleholder(s), is/are not entitled to any credits on account, leaving due unpaid and owing to the claimant on account thereof, the balance of TWO THOUSAND THREE HUNDRED EIGHTY-FIVE AND 74/100 (\$2,385.74), DOLLARS, for which, with statutory interest, the claimant claims a lien against the above described real estate.

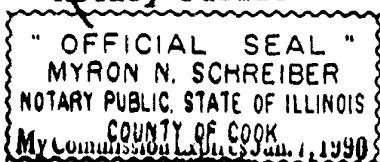
