That at the special instance and request of said owner the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$ 2,067.00 and completed same on June 12, 1989. (5)

That said owner is entitled to credits on account thereof as follows, to-wit:

leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of Twenty Nine Thousand Fifty Seven and 85/100 (\$29,057.85) Dollars, for which, with interest, the claimant claims a lien on said land and improvements.

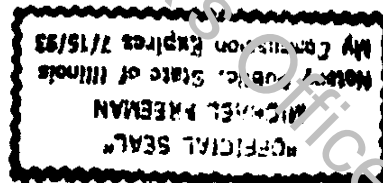
