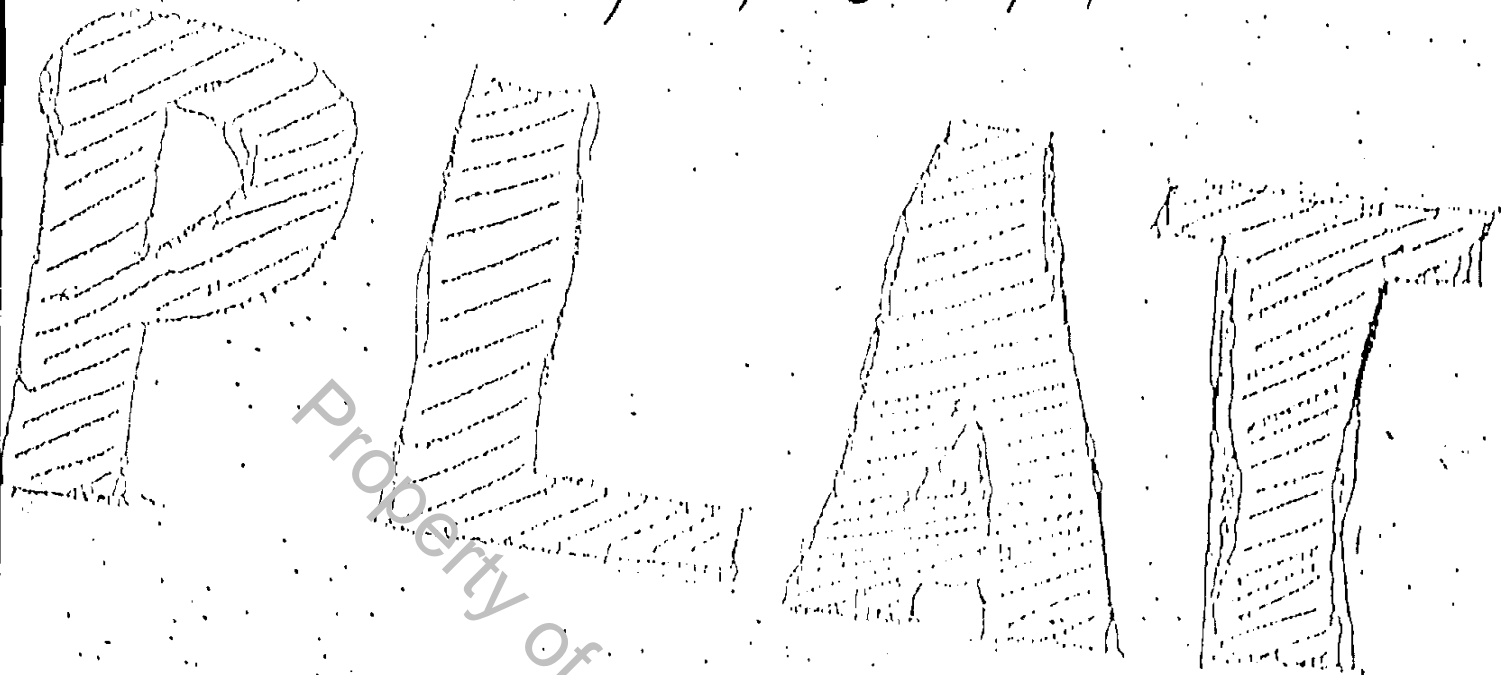

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF FRANKLIN PARK, COOK COUNTY, ILLINOIS THE METRA RAILROAD RIGHT-OF-WAY AND FRANKLIN AVENUE

WHEREAS, a written petition, signed by the legal owner of record of all land within the territory hereinafter described, has been filed with the Village Clerk of the Village of Franklin Park, Cook County, Illinois, requesting that said territory be annexed to the Village of Franklin Park; and

WHEREAS, there are no electors residing within the said territory; and

WHEREAS, the said territory is not within the corporate limits of any municipality, but is contiguous to the Village of Franklin Park; and

WHEREAS, legal notices regarding the intention of the Village to annex said territory have been sent to all public bodies required to receive such notice by State statute; and

WHEREAS, copies of such notices have been recorded in the Office of the Recorder of Deeds of Cook County; and

WHEREAS, the legal owner of record of said territory and the Village of Franklin Park have entered into a valid and binding annexation agreement relating to such territory; and

WHEREAS, all petitions, documents and other necessary legal requirements are in full compliance with terms of said annexation agreement and with the statutes of the State of Illinois, specifically Chapter 24, Section 2-1-9, Illinois Revised Statutes; and

WHEREAS, it is in the best interests of the Village of Franklin Park that said territory be annexed thereto;

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Franklin Park, Cook County, Illinois, as follows:

SECTION 1. That the territory as described on the attached Exhibit "A", which is incorporated herein by specific reference and thereby made a part hereof, including all other adjoining highways as required by State law being indicated on an accurate map of the annexed territory, which map is appended hereto and

made a part hereof, is hereby annexed, added to, taken in and made a part of the corporate territorial limits of the Village of Franklin Park, Cook County, Illinois.

SECTION 2. That the Village Clerk is hereby directed to record with the Recorder of Deeds and to file with the County Clerk a certified copy of this Ordinance, together with the accurate map of the territory annexed appended hereto.

SECTION 3. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

THAT CERTAIN PORTION OF THE RIGHT OF WAY OF FRANKLIN AVENUE BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

A PARCEL OF LAND CONVEYED TO THE COUNTY OF COOK BY DEEDS RECORDED IN THE RECORDER'S OFFICE OF SAID COOK COUNTY AS DOCUMENTS 17696458 AND 17808231 CONSISTING OF THAT PART OF SECTION 20, TOWNSHIP 40 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, FALLING WITHIN A STRIP OF LAND 100 FEET IN WIDTH, THE CENTERLINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT 673.60 FEET WEST OF AND 17 FEET NORTH OF THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION (AS MEASURED ON THE SOUTH LINE OF SAID NORTHEAST QUARTER AND AT RIGHT ANGLES THERETO);

THENCE NORTHWESTERLY ON A CURVED LINE, CONVEX NORTHEASTERLY, HAVING A RADIUS OF 14,295.10 FEET TO A POINT ON THE WEST LINE OF THE NORTHWEST QUARTER OF SAID SECTION 20, SAID POINT BEING 647.50 FEET NORTH OF THE SOUTHWEST CORNER OF SAID NORTHWEST QUARTER AFORESAID;
