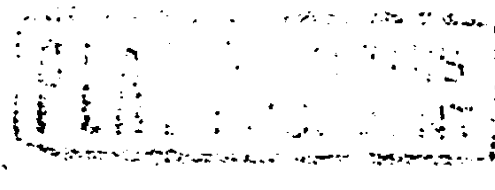

ORDINANCE NO. 13-1990

AN ORDINANCE FOR THE VACATION OF A CERTAIN  
ALLEY IN THE VILLAGE OF HAZEL CREST, ILLINOIS

WHEREAS, a public alley identified as all of the east-west alley and all of the north-south alley in Block 9 in South Harvey Land Company's Subdivision of the northeast 1/4 of the northeast 1/4 of Section 30, Township 36 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois, has heretofore been dedicated; and

WHEREAS, the owner of the property abutting the above described alley has requested that said alley be vacated; and

WHEREAS, the Village of Hazel Crest Zoning Board of Appeals did, on May 7, 1990, refer the request for vacation of said alleys to the Village Board of Trustees; and

WHEREAS, the Illinois Bell Telephone Company, the Northern Illinois Gas Company, and the Commonwealth Edison Company have all approved this alley vacation by their signatures on the Plat of Vacation; and

WHEREAS, the Village of Hazel Crest Plan Commission, at their meeting of July 9, 1990, did approve said Plat of Vacation; and

WHEREAS, the public interest is and will be best served by vacation of said alley.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HAZEL CREST, COUNTY OF COOK, STATE OF ILLINOIS, as follows:

## SECTION 1

The alley legally described as all of the east-west alley and all of the north-south alley in Block 9 in South Harvey Land Company's Subdivision of the northeast 1/4 of the northeast 1/4 of Section 30, Township 36 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois, be and the same is hereby vacated.


