and in connection therewith and as part thereof, states as follows:

That on and prior to 06/30/88... RICHARD W. SLONINA and JUDY K. SLONINA, his wife (J)

was/were the owner(s) of the legally described property which is also commonly known as 1102 W CYPRESS Arlington Heights, Illinois, and received and benefited from water service from the Village of Arlington Heights, and continued to receive benefit through the use of said water through 03/31/90 and incurred a total charge of \$ 876.75 from the Village of Arlington Heights, which became due and owing on 05/01/90 by virtue account statements rendered on or before said date; and twenty-one (21) days after said due and owing date, a penalty in an amount equal to ten percent (10%) of said amount was added as a penalty for failure to make prompt payment for a total sum of \$ 964.43 and twenty-one (21) days thereafter, to wit on 06/11/90 said account became delinquent, in accordance with the ordinance of the Village of Arlington Heights.

That there is still due, unpaid and owing to the Claimant the balance of \$ 964.43 for which, with costs of \$ 75.00 the Claimant claims a lien on said land and improvements in the total sum of \$ 1039.43

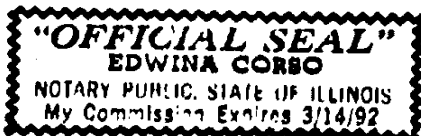
