**AN ORDINANCE ANNEXING CERTAIN PORTIONS
OF WILLIAMS ROAD**

WHEREAS, part of the dedicated western portion of Williams Road was annexed to the Village of Hoffman Estates by Ordinance No. 69-1962; and

WHEREAS, part of the dedicated eastern portion of Williams Road has been annexed to the Village of Hoffman Estates by Ordinance No. 949-1978; and

WHEREAS, the Village of Inverness is desirous of annexation of a portion of said land and territory, pursuant to Section 7-1-25 of the Illinois Municipal Code; and

WHEREAS, the President and Board of Trustees of the Village of Hoffman Estates, Cook and Kane Counties, Illinois, did by Ordinance No. 1309-1891 provide for the disconnection and exclusion from the Village of Hoffman Estates of the following described territory, being a dedicated street known as Williams Road which is contiguous to the Village of Inverness, to wit:

The West 33 feet, except the South 40 feet thereof, of the Southeast quarter of the Northeast quarter of Section 19, Township 42 North, Range 10 East of the Third Principal Meridian, in Cook County, Illinois, and the East 33 feet, except the South 40 feet thereof, of the Southwest quarter of the Northeastern quarter of Section 19, Township 42 North, Range 10 East of the Third Principal Meridian, in Cook County, Illinois,

provided, however, pursuant to Section 7-1-25 of the Illinois Municipal Code as aforesaid, such exclusion and disconnection was not effective until said territory is annexed to the Village of Inverness; and

WHEREAS, such disconnections and annexations are authorized by Illinois Revised Statutes, Chapter 24, Section 7-1-25, which section provides as follows:

"Any unoccupied territory, lying along the boundary line between 2 adjoining municipalities, may be excluded from one of the adjoining municipalities and annexed to the other adjoining municipality, as follows:

"The corporate authorities of the excluding municipality shall adopt an ordinance providing for such exclusion, and the corporate authorities of the annexing municipality shall adopt an ordinance providing for the annexation of this territory. Upon the adoption of these ordinances, the territory is thereby excluded from the one municipality and annexed to the other. The chief executive officer of each municipality thereupon shall file for recordation an accurate map of the excluded or added territory, as the case may be, together with a certified copy of the ordinance for exclusion or annexation with the recorder of the county in which the excluded or added territory, as the case may be, is situated."

WHEREAS, there are no electors residing within said territory and said territory is unoccupied; and

WHEREAS, notice regarding the intention of the Village to annex said territory has been sent to all public bodies required by law to receive such notice, if any, at least ten (10) days in advance of the consideration of this ordinance; and

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Inverness, Cook County, Illinois, that:

SECTION 1: The corporate authorities find that the statements in the preamble of this Ordinance are true.

SECTION 2: Pursuant to Section 7-1-25 of the Illinois Municipal Code, there is hereby annexed to the Village of Inverness the territory as legally described on Exhibit A.

SECTION 3: The Village hereby accepts dedication of and maintenance jurisdiction for the right-of-way of Williams Road as a public Village street which is contained within the aforesaid territory provided, however, the 48" storm sewer running generally North to South, the sanitary sewer mains, and the water mains which are all located underground in the unpaved portions of said right-of-way within said territory and which were constructed by or under the supervision of the Village of Hoffman Estates are not accepted by this ordinance and this annexation, and said storm sewer, sanitary sewer mains, and the water mains shall be and remain under the maintenance jurisdiction of the Village of Hoffman Estates and shall be the sole responsibility of said Village of Hoffman Estates.

SECTION 4: An accurate map of the territory hereby annexed, prepared by a registered land surveyor registered under the laws of the State of Illinois who has had training in the field of Civil Engineering, certified as correct by the Village Clerk, shall be filed with the Recorder of Deeds upon recording of this Annexation Ordinance, all as required by law.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage and approval pursuant to law.
