## EXTENSION AGREEMENT AND MODIFICATION OF MORTGAGE

WHEREAS, the Mortgagor has requested, and Bank has agreed to an extension of the maturity and a modification of the terms and conditions of the aforesaid loan,

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. The unpaid balance of the Note is currently Sixteen Thousand Seventy-Six and 68/100 Dollars (\$16,076.68);
2. The maturity of the Note is hereby extended from August 14, 1990 to February 11, 1991.
3. The monthly installments of interest, shall begin September 11, 1990 and continue the eleventh day of each month thereafter, until maturity. Interest shall be payable on the Note, as extended, at the rate of one and one-half percent (1.50%) per annum over the prime rate of First State Bank & Trust Company of Park Ridge as determined from time to time. Interest after maturity, whether by acceleration or otherwise, shall be at the rate of five and one-half percent (5.50%) per annum over said prime rate. Interest shall be computed on the basis of a 360 day year for the actual number of days elapsed.
