ORDINANCE NO. 90-10

#### AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE GLENVIEW PARK DISTRICT, COOK COUNTY, ILLINOIS

WHEREAS, the Glenview Park District, Cook County, Illinois has heretofore been duly organized and is now operating under the provisions of an Act of the General Assembly of the State of Illinois, entitled "The Park District Code", as amended by an Act approved May 17, 1951, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the Glenview Park District is operating within territory predominately in the Village of Glenview, as well as within the Villages of Golf and Viles; and

WHEREAS, cortain territory hereinafter described has been recently annexed to the Vi'lage of Glenview; and

WHEREAS, all the territory within the Village of Glenview, except for the territory described in Section 1, is also within the territorial boundaries of the Glenview Park District and it is the desire of the Board of Commissioners that all territory located within the said Village of Glenview be within the Glenview rark District and by annexing said territory, the boundaries of the Glenview Park district would become nearly coterminous with the said Village of Glenview; and

whereas, the Board of Park Commissioners of the Glenview Park District have determined that the said additional territory is less than one hundred and twenty (120) acres and is within the said Village of Glenview but not incorporated within a park district.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE GLENVIEW PARK DISTRICT, COOK COUNTY, ILLINOIS.

Section 1: That the following described territory:
