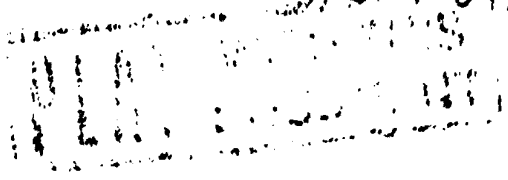

ORDINANCE NO. 90-12

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE
GLENVIEW PARK DISTRICT, COOK COUNTY, ILLINOIS

WHEREAS, the Glenview Park District, Cook County, Illinois has heretofore been duly organized and is now operating under the provisions of an Act of the General Assembly of the State of Illinois, entitled "The Park District Code", as amended by an Act approved May 17, 1951, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the Glenview Park District is operating within territory predominately in the Village of Glenview, as well as within the Villages of Golf and Mies; and

WHEREAS, certain territory hereinafter described has been recently annexed to the Village of Glenview; and

WHEREAS, all the territory within the Village of Glenview, except for the territory described in Section 1, is also within the territorial boundaries of the Glenview Park District and it is the desire of the Board of Commissioners that all territory located within the said Village of Glenview be within the Glenview Park District and by annexing said territory, the boundaries of the Glenview Park district would become nearly coterminous with the said Village of Glenview; and

WHEREAS, the Board of Park Commissioners of the Glenview Park District have determined that the said additional territory is less than one hundred and twenty (120) acres and is within the said Village of Glenview but not incorporated within a park district.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE GLENVIEW PARK DISTRICT, COOK COUNTY, ILLINOIS.

Section 1: That the following described territory:

THE WEST 529.80 FEET OF THE EAST 2118.25 FEET OF THE NORTH 280.00 FEET OF THE SOUTH 330.00 FEET OF THE SOUTH 1/2 OF THE NORTH 1/2 OF THE NORTHEAST 1/4 OF SECTION 20, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

be and the same is hereby annexed to the Glenview Park District, Cook County, Illinois, pursuant to the provisions of Section 3-10 of the Park District Code as amended.

Section 2: That this Ordinance shall be effective upon its passage and approval according to law.
