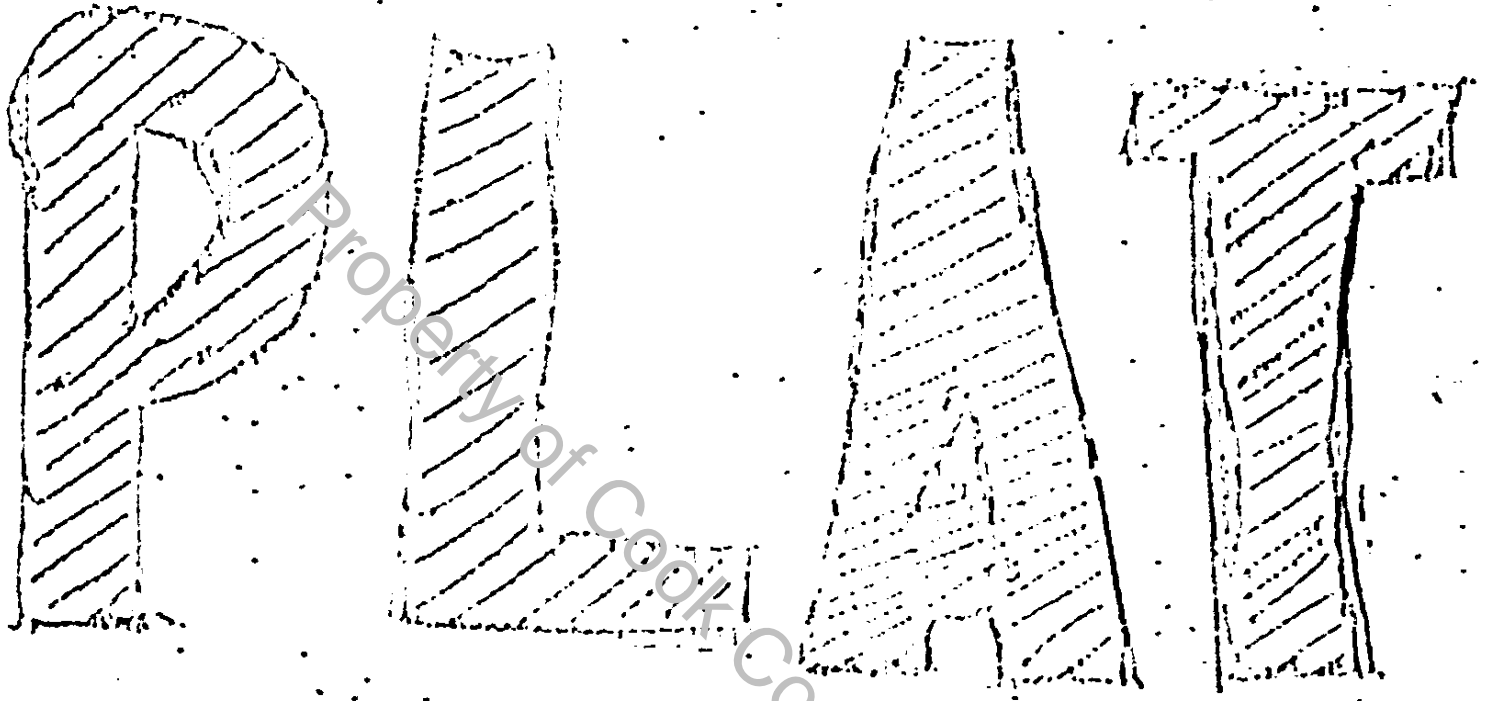

ORDINANCE NO. 90-48

AN ORDINANCE ANNEXING CERTAIN SURROUNDED  
TERRITORY TO THE CITY OF ROLLING MEADOWS, ILLINOIS  
(Southeast Corner of Kirchoff Rd. and Benton St.)

WHEREAS, Chapter 24, Sec. 7-1-13 of the Illinois Revised Statutes, provides that unincorporated territory containing 60 acres or less, wholly bounded by one or more municipalities, may be annexed by a municipality by which it is bounded in whole or in part by the passage of an ordinance to that effect after notice is given, as provided by said statutory section; and

WHEREAS, the hereinafter legally described territory is wholly bounded by the City limits of the City of Rolling Meadows; and

WHEREAS, the City Council has caused notice, pursuant to said statute, of the contemplated annexation of said territory hereinafter described, to be published once in a newspaper of general circulation within the territory to be annexed not less than ten (10) days before the passage of an annexation ordinance; and

WHEREAS, notice upon the Trustees of the Palatine Township Fire Protection District and the Palatine Library District have been served as required by the Illinois Revised Statutes; and

WHEREAS, the City Council is of the opinion that the annexation of said territory is in the best interests of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROLLING MEADOWS, COOK COUNTY, ILLINOIS, as follows:

SECTION ONE: The following territory, be and the same, is hereby annexed to the City of Rolling Meadows pursuant to Chapter 24, Section 7-1-13 of the Illinois Revised Statutes:

Lots 3, 4, 5, 6 and the West 50 Feet of Lot 2 in Arthur T. McIntosh and Company's Palatine Estates Unit No. 3, being a Subdivision of parts of Section 26 and 27, Township 42 North, Range 10, East of the Third Principal Meridian, in Cook County, Illinois.

SECTION TWO: The Mayor of the City of Rolling Meadows is hereby directed to record in the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this Ordinance together with the correct map of the territory annexed.
