ADDENDUM

That part lying North of the South 110 feet and South of the North 110 feet as measured on the East and West lines thereof of a tract described as that part of Lots 13 and 14 in Assessors Division of the North West 1/4 of Section 14, Township 41 North, Range 13, East of the Third Principal Meridian described as follows: Beginning at a point on the East line of said Lot 14 (being also the East line of the South West 1/4 of the North West 1/4 of said Section 14) 173 feet North of the South East corner thereof, continuing thence North along the East line of said Lots 13 and 14 a distance of 284.39 feet; thence West along a line making an angle of 91 degrees 47 minutes 20 seconds (as measured from North to West) with the prolongation of the last described line 163.81 feet; thence South parallel with the East line of said South West 1/4 of the North West 1/4, 284.39 feet to a line 173.0 feet (as measured along the said East line) North of and parallel with the South line of said South West 1/4 of the North West 1/4; thence East along said last mentioned parallel line 163.81 feet to the place of beginning (except therefrom the East 33 feet thereof for public road) all in Cook County, Illinois.
