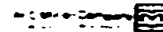

MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on JUNE 25 1990. The mortgagor is Dorota Kowalska and Marian W. Kowalski, his wife ("Borrower"). This Security Instrument is given to MSI Bank of Racine, which is organized and existing under the laws of Wisconsin, and whose address is MSI Bank of Racine, P.O. Box 757, Racine, Wisconsin 53401-0757 ("Lender"). 19. Acceleration; Remedies. Lender shall give notice to Borrower prior to acceleration following Borrower's breach of any covenant or agreement in this Security Instrument (but not prior to acceleration under paragraphs 13 and 17 unless applicable law provides otherwise). The notice shall specify: (a) the default; (b) the action required to cure the default; (c) a date, not less than 30 days from the date the notice is given to Borrower, by which the default must be cured; and (d) that failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Security Instrument and sale of the Property. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to bring a court action to assert the non-existence of a default or any other defense of Borrower to acceleration and sale.
