It is further agreed that said modified balance of \$225,000.00 shall bear increst at the rate of First Colonial Bankshares Corporation's prime rate of interest plus one per cent per annum floating for ONE (1) vear beginning August 30, 1990 and continuing during the term hereof, and at the aforementioned rate of interest plus an additional three per cent per annum upon default or after maturity, and shall be payable in quarterly installments of interest only beginning on the 30th day of November, 1990 and continuing on the 30th day of each and every successive quarter thereafter until the 30th day of August, 1991, at which time the entire outstanding balance of principal plus interest shall be due, if not sooner paid.

In all other respects said Note or other obligation and said trust deed shall remain unchanged and be in full force and effect.
