That on and prior to 02/28/89...CARL V. WASMUND, JR. & JACQUELINE J. WASMUND, HIS WIFE (J)

was/were the owner(s) of the legally described property which is also commonly known as 1100 E ROCKWELL Arlington Heights, Illinois, and received and benefited from water service from the Village of Arlington Heights, and continued to receive benefit through the use of said water through 02/28/90 and incurred a total charge of \$ 226.23 from the Village of Arlington Heights, which became due and owing on 03/01/90 by virtue account statements rendered on or before said date; and twenty-one (21) days after said due and owing date, a penalty in an amount equal to ten percent (10%) of said amount was added as a penalty for failure to make prompt payment for a total sum of \$ 248.85 and twenty-one (21) days thereafter, to wit on 04/11/90 said account became delinquent, in accordance with the ordinance of the Village of Arlington Heights.
