INITLAL MEETING OF THE ASSOCIATION MEMBERSHIP

THURSDAY MARCH 21, 1974

The first meeting of the Unit Owners of the Shoreline Condominium Association formerly, the Shoreline Cooperative Apartments, was called to order at 8:15 P.M. on Thursday, March 21, 1974 by Mr. Harold Summerfield, retiring President of the Shoreline Cooperative Association, acting as Chairman of the Meeting. In his preliminary remarks, Mr. Summerfield expressed pleasure and gratitude on behalf of all the Owners for the change from a Cooperative to a Condominium Association and for the work of all who helped bring about this change.

The first order of business was to amend the new Condominium Declaration so as to allow for a change in the number of Directors from seven to nine. The motion was forthwith made and seconded that the Shoreline Condominium Declaration of Ownership be amended as to the number of elected Directors from seven members to nine. The chairman called for a voice vote which was given unanimously in favor of the amendment. The amendment was therefore passed.

Mr. Ernest Taylor, Chairman of the Nominating Committee, was called upon next to present to the Association the slate of candidates for election to the Board of Directors. The Mominees so presented were as follows in alphabetical order: Mr. Walter Slack, Mrs. Barbara Calero, Mr. Jack Marks Mr. Robert Minor, Mr. Robert Rolin, Mr. C.J. Sullivan, Mr. Harold Summerfield, Mr. Bismark Williams, and Mrs. Peggy Williams. The Chair then called for nominations from the floor. Mr. Novak nominated Mrs. Susan Friedland. Mr. Spivey nominated Mrs. Helen Brooks, Mr. Sullivan then asked that his name be withdrawn from nomination since his apartment was currently on the market although he had no prospects. Mr. Spivey next nominated Mr. Donald Pruitt. Ms. Jeannette Allen nominated Mr. Charles Spivey who respectfully declined the acainstion due to lack of time to attend the meetings. Mr. Marks and then Mr. Pruitt asked that Mr. Sullivan reconsider his decision to withdraw his name from nomination since they felt his experience on the Board in the past would be of great value. Mr. Sullivan they changed his decision and allowed his name to stand for nomination. It was then moved that nominations from the floor be closed; this was seconded and paysed. The final slare of nominues then consisted of the original nine nominues plus the three nominees from the floor, Mrs. Friedland, Mrs. Brooks and Mr. Pruitt. Ballots were then distributed and the vote taken. Forty one ballots (including some proxies) were cast and with 85,628% of the Owners votes being cast, the results were as follows: Those elected were Walter Black, Jack Marks, Robert Minor, Robert Rosin, C.J. Sullivan, Harold Summerfield, Bismark Williams, Mrs. Peggy Williams, and Mr. Donald Pruitt.

Under "old business" Mr. James Williams requested of the Board that a financial statement on the closing of the Shoreline Cooperative be presented to the Owners as soon as possible. Mr. Summerfield assured him that the matter would be taken up by the new Board and a report made to the Owners. Under new business, Mr. Spivey inquired about the status of the Condominium regarding any City building code violations. None are known at this time; future code changes will be taken up by the Board. Mr. Spivey also requested that Owners be advised of what list of priorities the Board proposed to follow in the work to be done in the coming year. The Board will advise the Owners in due time.

The initial Meeting of the Shoreline Condominium Association was then adjourned.
