WHEREAS, The City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of public alley described in the following ordinance, now, therefore,

*Be it Ordained by the City Council of the City of Chicago*

SECTION 1. That all that part of the north-south 14-foot public alley lying west of the west line of Lots 1 and 4, lying east of the east line of Lots 2 and 3, lying south of a line drawn from the northeast corner of Lot 3 to the northwest corner of Lot 4, and lying north of a line drawn from the southeast corner of Lot 2 to the southwest corner of Lot 1, all in Block 2 in Adam Murray's Addition to Chicago in the west half of the northwest quarter of Section 28, Township 39 North, Range 14 East of the Third Principal Meridian, said part of public alley herein vacated being further described as the south 43 feet of the north-south 14-foot public alley in the area bounded by the Stevenson Expressway, West 26th Street, South Halsted Street and South Emerald Avenue as colored in red and indicated by the words "To

**SECTION 6** This ordinance shall take effect and be in force from and after its passage.

**SECTION 2** The City of Chicago hereby reserves for the benefit of Commonwealth Edison Company and Illinois Bell Telephone Company, their successors or assigns, an easement to operate main transmission facilities, and to lay, support and maintain associated equipment, and underground conduits, cables, and other appurtenant works and fixtures, over, and along part of the public alleys as herein vacated, with the right of ingress and egress.

**BE VACATED**...on the drawing hereto attached which drawing for public interest is hereby vacated and discarded, inasmuch as made a part of this ordinance be and the same is hereby vacated and discarded.




